## You may need **legal** help when...

- 1. You cannot get your lender to call you back or are being referred to multiple people with no answers
- 2. You received a legal notice in the mail or on your door or were served papers
- 3. You or your HUD housing counselor believes your rights were not respected
- 4. You or your HUD housing counselor see 'questionable' terms in any documents you have signed or been requested to sign
- 5. You have received notice of a pending foreclosure or an eviction notice due to foreclosure (if you are a tenant)
- 6. You are trying to work out a repayment or refinance agreement and not being given any documentation or answers that this will prevent foreclosure
- 7. You paid money in advance to a company who promises they will 'help you keep your home'

# Any of these sound like your situation?



**The Arizona Attorney General's Office** has provided funding from the National Mortgage Settlement for legal assistance to Arizonans impacted by the foreclosure crisis that swept our nation over the last several years. To assure the funds available help the people most in need, there are certain criteria set to receive free legal assistance:

- 1. Your primary residence is the home being or has been foreclosed on
- 2. The house is in the State of Arizona
- 3. Your household income is at or below 150% of your Area Median Income

## 150% of Area Median Income. What is that?



# Having this information with you will help make the most of your legal aid appointment:

- 1) Identification verification (your ID, your SS numbers of homeowners)
- 2) Address of foreclosed home
- 3) Loan documents (if tenant in foreclosed home, bring lease) and payment records
  - Housing deed/financial loan agreement, and sales documents
- 4) Contact information of your lender
- 5) Any documents or records of correspondence with your lender
- 6) Any documents you received from the court, were served to you, or were posted on your door
- 7) Record of your housing payment history
