GENERAL INFORMATION

USE AND DISCLAIMER

These forms shall not be used to engage in the unauthorized practice of law. Court cases can be very complicated, and even if you are representing yourself you should see a lawyer for legal advice as to how the law applies to you, and what is best in your particular situation. This might save you time, money, trips to the courthouse, and avoid serious mistakes. There are lawyers who will help you help yourself. This means that they will only charge you for giving you the help you need, and you can complete the court papers on your own or ask the lawyer for help with your papers.

There are professional mediators in the community who can help you with your problems. They help you solve your present problem, and anticipate future problems and how to solve them. Mediators work with both parties in a dispute to help resolve areas of disagreement or trouble.

HOW TO ASSEMBLE THESE DOCUMENTS

This packet contains court forms and instructions about Court Mediation Services. Be sure the documents are in the following order. Look at the lower right-hand corner of the document for the document number. Documents that end with "info" are general information or instructions. Documents that end with "form" are court forms that must be completed and filed with the court.

To request mediation for disputes involving custody or parenting time of minor children, complete the attached

REQU	EST FOR MEDIATION in the following manner:		
	Write your Superior Court file number on the top right portion of the form. Most file numbers begin with D- or SP You <u>must</u> have a D-, SP-, DC-, G- or C- number before the Court can order mediation.		
	Complete the information in the box in the upper left hand corner of the form by placing the n petitioner and respondent in the box. If you filed for the divorce (or other court action), you are the Write your name just above "Petitioner," and the other parent's name above "Respondent." If the filed for the original case, then you are the Respondent and the other party is the Petitioner.		
	If you have never been married to the other parent th action above "Plaintiff" and the other parent's name about		
	Check the line next to the nature of the controversy between you and the other parent: custody , parentitime , or both . Check the line to indicate which party is requesting mediation: If you are the person requesting this mediation and you are/were the Petitioner of the divorce then put a check by petitioner. If you are the person requesting this mediation and you are the Respondent to the divorce filling, then put a check by respondent.		
	Check if a decree of dissolution (divorce) has or has not been granted by the court in this case. Enter the date of the decree. Check if there is or is not an action currently pending before the court.

	Fill in the number of children and their ages.		
	Print clearly the name, address and daytime phone number of yourself and the other party on the lowe portion of the form.		
	Clearly print the name of your attorney and the attorney of the other party on the lines as indicated. If a part does not have an attorney write NONE.
